WMGU "VILLE CITY BLUES FESTIVAL 2023 PHASE 2" ONLINE CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WMGU ("Station"), 1009 Drayton Road, Fayetteville, NC 28303, during available business hours Monday through Friday, on the Station website www.magic1069.com, by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WMGU "VILLE CITY BLUES FESTIVAL 2023 PHASE 2" ONLINE CONTEST (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. This Contest is open only to legal U.S. residents excluding Florida or New York residents twenty one (21) years or older, at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize valued at \$200 more in the 90 days, and whose immediate family members or household members have not won a prize from the Station in the last 90 days of a prize valued at \$200 or more in the 90 days. Online: Visit the Station's website www.MAGIC1069.com during the Contest Period, click on the "Contest" link, click on the "Enter to win Ville City Blues Festival" Contest link, and complete an entry form. All entries must be received by 12:00 pm ET on October 27, 2023 to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.
- **4. Winner Selection.** On or around **12:00 pm ET, October 27, 2023,** Station will select five (5) entries for a Prize in a random drawing from among all valid entries received by Station that day of the Contest. The winning entrant may be contacted using the telephone number used to submit the entry and may be

awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact or claim the prize within one (1) day of winning will result in disqualification and forfeiture of the prize

- 5. Verification of Potential Winner. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
