## WMGU "KEYSHIA COLE THE WAY IT IS 20TH ANNIVERSARY TOUR 2025" ONLINE CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WMGU ("Station"), 1009 Drayton Road, Fayetteville, NC 28303, during available business hours Monday through Friday, on the Station website www.magic1069.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WMGU "KEYSHIA COLE THE WAY IT IS 20TH ANNIVERSARY TOUR 2025" ONLINE CONTEST (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
